# ORDINANCE NO. 1168

AN ORDINANCE REPEALING ORDINANCE NO. 846, ROCKPORT FOOD SERVICE ORDINANCE, OF THE CITY OF ROCKPORT, TEXAS, BY SETTING OUT RULES, MAKING CERTAIN CHANGES, DELETIONS AND ADDITIONS TO THE REGULATION OF FOOD ESTABLISHMENTS AS HEREINAFTER SET OUT; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROCKPORT, TEXAS:

The Code of Ordinances of the City of Rockport is hereby amended as follows:

#### SECTION 1. REPEAL

That Chapter 54, Article II. Food Service is hereby repealed in its entirety.

# SECTION 2. ADOPTION

That the following is hereby adopted as a new Article II. Food Establishment Rules to the City of Rockport Code of Ordinances:

## ARTICLE II. FOOD ESTABLISHMENTS

Section 54-26. Adoption of Texas Food Establishment Rules

- a. The City of Rockport adopts by reference the provisions of the current rules or rules as amended by the Texas Board of Health found in 25 Texas Administrative Code, Chapter 229, Sections 161 through 171 and 173 through 175 regarding the regulation of food establishments in this jurisdiction.
- b. Definitions.

The words "Authorized agent or employee" mean the employees of the regulatory authority.

The words "food establishment" mean a food service establishment, a retail food store, a mobile food unit, and/or a roadside food vendor.

The words "municipality of Rockport" in this article shall be understood to refer to the City of Rockport.

The words *"state rules"* mean the state rules found at 25 Texas Administrative Code, Chapter 229, Sections 161 through 171 and Sections 173 through 175. These rules are also known as the Texas Food Establishment Rules.

The words *"regulatory authority"* mean the Aransas County Environment & Health Department who has jurisdiction over food establishments.

Section 54-27. Permits and Exemptions.

- a. A person may not operate a food establishment without a permit issued by the regulatory authority. Permits are not transferable from one period to another or from one location to another location, except as otherwise permitted by this ordinance. A valid permit must be posted in or on every food establishment regulated by this ordinance.
- b. A food establishment operated solely by a nonprofit organization is exempt from the permitting requirements of this ordinance, but is not exempt from compliance with state rules. The regulatory authority may require any information necessary to determine whether an organization is nonprofit for purposes of this exemption.

Section 54-28. Application for Permit and Fees.

- a. Any person desiring to operate a food establishment must make a written application for a permit on forms provided by the regulatory authority. The application must contain the name and address of each applicant, the location and type of the proposed food establishment and the applicable fee. An incomplete application will not be accepted. Failure to provide all required information, or falsifying information required may result in denial or revocation of the permit. Renewals of permits are required on an annual basis and the same information is required for a renewal permit as for an initial permit.
- b. Prior to the approval of an initial permit or the renewal of an existing permit, the regulatory authority shall inspect the proposed food establishment to determine compliance with state laws and rules. A food establishment that does not comply with state laws and rules will be denied a permit or the renewal of a permit.
- c. The following fee schedule applies to permits issued under this ordinance:

Permits are required for all temporary events such as carnivals, festivals or other related events if they sell food or beverages to the public. The regulatory authority does not differentiate between full-time and part-time employees. All food-service permits are required and must be paid prior to the last working day in January.

## Section 54-29. Review of Plans

a. Whenever a food establishment is constructed or extensively remodeled and whenever an existing structure is converted to use as a food establishment, properly prepared plans and specifications for such construction, remodeling or conversion shall be submitted to the City of Rockport for review before work is begun. Extensive remodeling means that 20% or greater of the area of the food establishment is to be remodeled. The plans and

specifications shall indicate the proposed layout, equipment arrangement, mechanical plans and construction of materials of work areas, and the type and model of proposed fixed equipment and facilities. The City of Rockport will approve the plans and specifications if they meet the requirements of the rules adopted by this ordinance. The approved plans and specifications must be followed in construction, remodeling or conversion.

b. Failure to follow the approved plans and specifications will result in a permit denial, suspension, or revocation.

### Section 54-30. Suspension of Permit

- a. The regulatory authority may, without warning, notice, or hearing suspend any permit to operate a food establishment if the operation of the food establishment constitutes an imminent hazard to public health. Suspension is effective upon service of the notice required by Paragraph b of this ordinance. When a permit is suspended, food operations shall immediately cease. Whenever a permit is suspended, the holder of the permit shall be afforded an opportunity for a hearing within twenty (20) days of receipt of a request for a hearing.
- b. Whenever a permit is suspended, the holder of the permit or the person in charge shall be notified in writing that the permit is, upon service of the notice, immediately suspended and that an opportunity for a hearing will be provided if a written request for a hearing is filed with the regulatory authority by the holder of the permit within ten (10) days. If no written request for hearing is filed within ten (10) days, the suspension is sustained. The regulatory authority may end the suspension at any time if reasons for suspension no longer exist.

### Section 54-31. Revocation of Permit

- a. The regulatory authority may, after providing opportunity for a hearing, revoke a permit for serious or repeated violations of any of the requirements of these rules or for interference with the regulatory authority in the performance of its duties. Prior to revocation, the regulatory authority shall notify the holder of the permit or the person in charge, in writing, of the reason for which the permit is subject to revocation and that the permit shall be revoked at the end of the ten (10) days following service of such notice unless a written request for a hearing is filed with the regulatory authority by the holder of the permit within such ten (10) day period.
- b. If no request for hearing is filed within the ten (10) day period, the revocation of the permit becomes final.

### Section 54-32. Administrative Process

- a. A notice as required in these rules is properly served when it is delivered to the holder of the permit or the person in charge, or when it is sent by registered or certified mail, return receipt requested, to the last known address of the holder of the permit. A copy of the notice shall be filed in the records of the regulatory authority.
- b. The regulatory authority shall conduct the hearings provided for in these rules at a time and place designated by it. Based upon the recorded evidence of such hearing, the regulatory authority shall make final findings, and shall sustain, modify or rescind any notice or order considered in the hearing. A written report of the hearing decision shall be furnished to the holder of the permit by the regulatory authority.

#### Section 54-33. Remedies

- a. Any person who violates a provision of these rules and any person who is the permit holder of or otherwise operates a food service establishment that does not comply with the requirements of these rules and any responsible officer of that permit holder or those persons shall be guilty of a Class C Misdemeanor and shall be punished by a fine not exceeding \$500.00.
- b. The regulatory authority may seek to enjoin violations of these rules.

## Section 54-34. Food Service Education.

The Food Service Sanitation Course (2 hour course), Food Service Manager's Sanitation Course and Food Service Manager's Refresher Course shall be required for all employees, owners or managers of any food service operation respectively. The City of Rockport will contract with the Aransas County Environmental Health Office by Interlocal agreement to provide and arrange Food Service Education classes. Upon completion of the course the student shall receive a certificate of completion. Where possible, the food service permit shall indicate whether the manager or owner has completed the appropriate course.

# Section 54-35 Examination and condemnation of food.

The authorized agent or employee may examine food as often as necessary for the enforcement of this ordinance and the state laws and rules. The authorized agent may, upon written notice to the owner or person in charge, place a hold order on any food, which it believes is in violation of any state laws. A written notice must specify the reason for the hold order. The authorized agent shall tag, label, or otherwise identify any food subject to the hold order. No food subject to the hold order shall be used, served or moved from the establishment. The authorized agent shall permit storage of the food under conditions specified in the hold order, unless storage is not possible without risk to the public health, in which case immediate destruction shall be ordered and accomplished.

Section 54-36 - 54-55 Reserved for future use.

# SECTION 3. REPEALING CLAUSE

All sections of the Code of Ordinances of the City of Rockport, Texas, in conflict with this ordinance are hereby expressly repealed insofar as such conflict herewith, and all other ordinances not in conflict herewith, shall remain in full force and effect.

#### SECTION 4. SEVERABILITY.

Any previously adopted ordinances, and any subsequent amendments to them, which are in conflict with this Ordinance, are all hereby repealed.

### SECTION 5. EFFECTIVE DATE

This ordinance shall become effective upon adoption on second reading by the Rockport City Council and publication of the ordinance caption in the official newspaper of the City of Rockport.
